TERMS & CONDITIONS

The Sandra Blanchette Memorial Student Scholarship is to continue the legacy of a very special individual. Sandra was an Optician and Contact Lens Fitter who shared her passion for the industry everywhere she went. She worked across Canada throughout her career, teaching, mentoring, and inspiring the next generation of contact lens fitters. Sandra dedicated countless hours to the profession in her role as OAC Director, online instructor for NAIT, student Contact Lens workshop facilitator, as well as a member of the board for the Opticians of Manitoba and the College of Opticians of Alberta.

The Sandra Blanchette Memorial Student Scholarship is intended to provide financial support in the amount of \$1000 to one (1) student enrolled in Year One, Semester One of the NAIT Optical Sciences Eyeglasses Program or NAIT Optical Sciences Contact Lens Program across Canada.

ELIGIBILITY CRITERIA

- Scholarship applicant must be a Canadian Citizen or Permanent Resident of Canada
- Scholarship applicant must currently be enrolled in a full semester of NAIT courses for the Fall 2024 intake
- Scholarship applicant must be enrolled in Semester One of Eyeglasses Year One or Semester One of Contact Lenses

SCHOLARSHIP APPLICATION

Sandra Blanchette Memorial Student Scholarship applicants are required to complete all sections of the online Sandra Blanchette Memorial Student Scholarship application form. No other form will be considered.

Only one (1) Sandra Blanchette Memorial Student Scholarship application allowed per student applicant.

Completing more than one (1) Sandra Blanchette Memorial Student Scholarship Application may disqualify you from being considered for the scholarship.

Scholarship applications will be accepted June 15 to August 8, 2024.

The scholarship application period closes at 11:59 PM CT on August 8.

SELECTION PROCESS

The Sandra Blanchette Memorial Student Scholarship recipient will be randomly selected. The recipient will be contacted via email and announced by August 19, 2024.
