Criteria/Eligibility: Available to students residing in Ontario, entering the Optical Sciences - Contact Lenses

ELIGIBILITY CRITERIA

- Bursary applicant must be a Canadian Citizen or Permanent Resident and reside within the province of Ontario.
- Bursary applicant must be approved for enrollment in a full semester of NAIT courses in the Fall 2024 academic term.
- Bursary applicant must be approved for enrollment in Eyeglasses Year One, Eyeglasses Year Two or Contact Lenses.

OOA BURSARY APPLICATION

OOA Bursary applicants are required to complete all sections of the online Ontario Opticians Association Bursary Application form. No other form will be considered.

Only one (1) Ontario Opticians Association bursary application allowed per student applicant. Completing more than one (1) OOA bursary application may disqualify you from being considered for these bursaries.



OOA Bursary applicants must have fully completed the NAIT Optical Sciences application process for enrollment in their respective program prior to completing the bursary application. You do not need to wait for your acceptance into your program to apply for a bursary.

OOA Bursary applications will be accepted June 20 to August 8, 2024.

The application period closes at 11:59 PM CT on August 8.

SELECTION PROCESS

OOA Bursary recipients will be randomly selected. Recipients will be contacted and announced by August 19, 2024.
